## AFI TRADE INTELLIGENCE REPORTS

The AFI Trade Intelligence reports provide detailed entry data on imports of food items from bills of lading, including the consignee (the importer, in most cases), country of origin, foreign shipper, arrival date, ship line, point of origin, port of discharge, specific commodity, quantity in a declared unit of measure, total pounds and calculated value. The reports are provided monthly and offered on a per-commodity basis.
